**TERMS AND CONDITIONS**

Event Coordinator shall at the signing of this agreement agree to the minimum and specify maximum number of golfers. Event Coordinator shall furthermore, **at least eight (8) days prior to the date of the event**, notify SCC Golf Events Planner the exact number of golfers. This number shall constitute a new guaranteed minimum only if above the original contracted agreement minimum. The Event Coordinator will be charged accordingly.

**A Non-Refundable Deposit in the amount of \$500.00 payable to "Springfield Township" is required at signing of this the Agreement.** If Event Coordinator cancels prior to the event, then Event Coordinator is liable for the total price of the minimum number of golfers as agreed in the Agreement.

Payment in full of the entire Agreement price must be made at least eight (8) days prior to the date of the event and, if such payment is not made, Springfield Country Club may terminate this Agreement and may retain all or part of deposits and or payments as partial damages or on account of the full Agreement price.

Event Coordinator will submit a list of foursomes eight (8) days prior to the event date.

No outings will be scheduled on Fridays, Saturdays, Sundays, or Holidays.

**Liquor License Laws prohibits alcoholic beverages of any kind to be brought on to Springfield Country Club premises.** Neither Event Coordinator nor any of the Event Coordinator's guests or invitees may bring any food or beverages of any kind on to Springfield Country Club premises.
